

ARSENAL CREDIT UNION CUSTOMER RATINGS AND REVIEW TERMS OF USE AND LICENSE

These Terms of Use govern your conduct associated with the customer ratings, review and testimonial feature offered by **Arsenal Credit Union** (the "Feature"). Additionally, you waive any right to a jury trial. If any part of these Terms of Use is unlawful, void or unenforceable, that part will be deemed amended and enforced to the fullest extent possible and will not affect the validity and enforceability of any remaining provisions.
